## 1. RAW MATERIALS

### COMPOSITION AND RECYCLING

Our products are modular in design, comprising standardized components such as legs, corpses, crossbars and worktops. As only five types of screws are used, the furniture is easy to assemble, disassemble, repair or adapt using standard tools.

In line with the principles of the circular economy, we use recycled and recyclable materials as much as possible. The proportion of these materials depends on market availability. We aim to increase this proportion year on year.

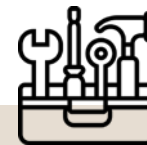
STEEL

## 5. REPAIRS

## WARRANTY

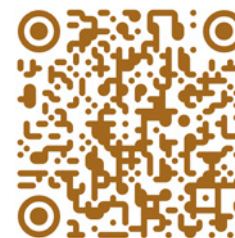

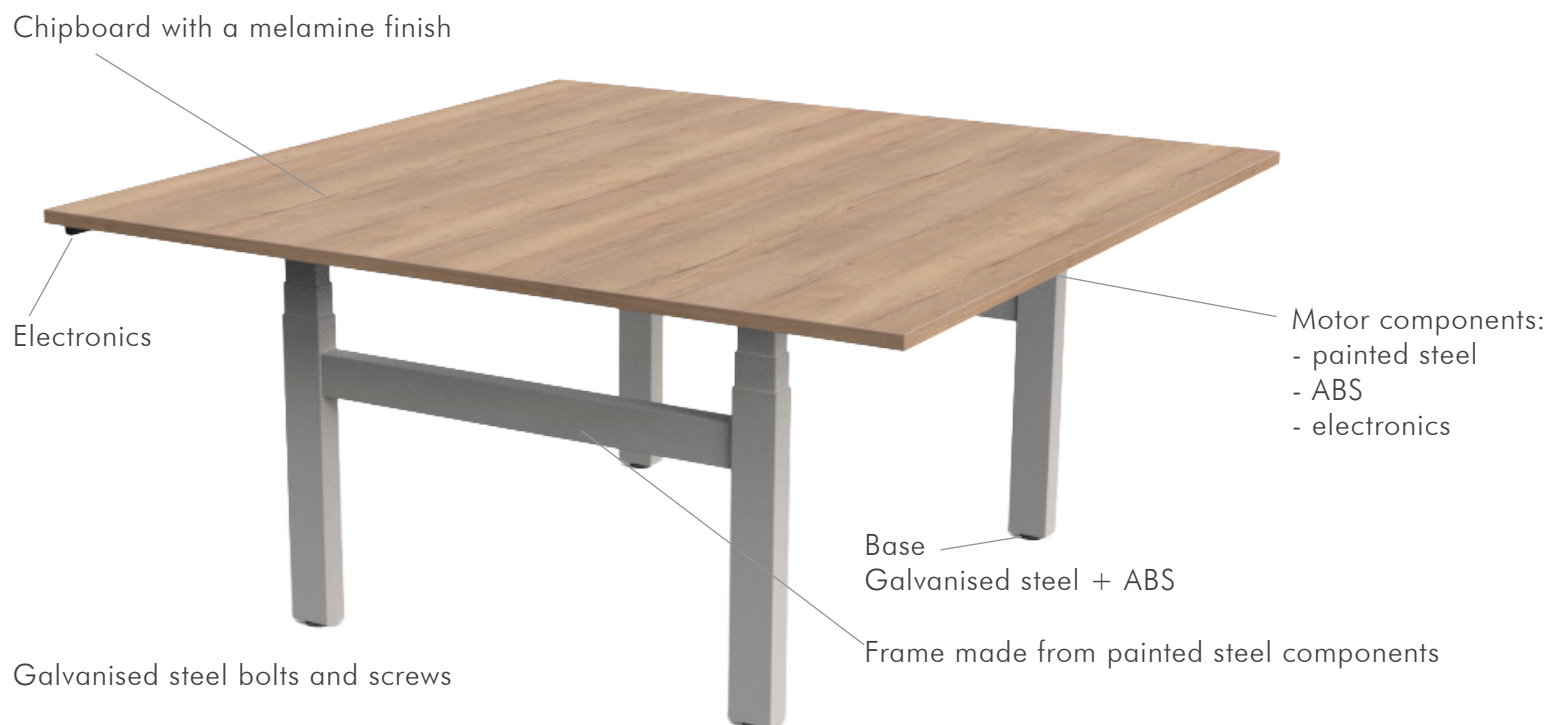

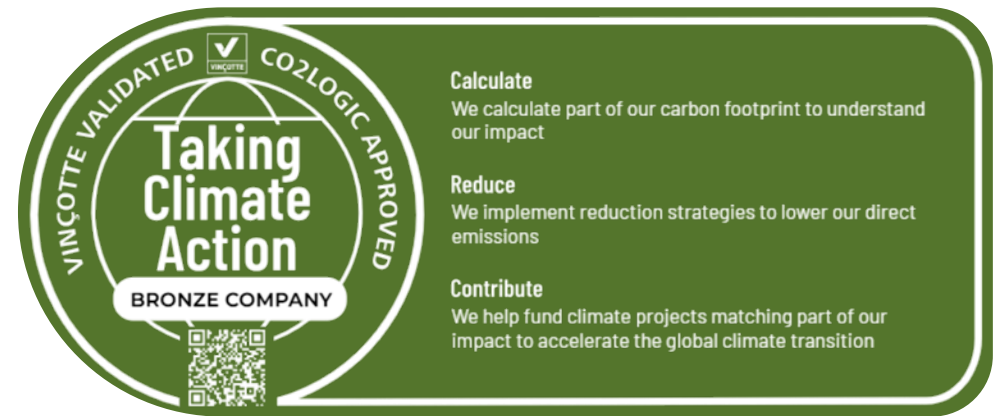
